Notice is hereby given, pursuant to Statute 22 and 23 Vic., Cap. 35, that all persons claiming to be creditors of, or otherwise to have any claim or demand against the Estate and effects of the above-named James Dunne, who died on the 31st day of January, 1933, are hereby required, on or before the 20th day of March, 1933, to furnish (in writing) particulars of such claims and demands to the undersigned Solicitors for the Administratrix, to whom Letters of Administration of the Estate of said Deceased were granted forth of the Principal Probate Registry of the High Court of Justice, Saorstát Eireann, on the 21st day of February, 1933.

And Notice is hereby further given that after the said 20th day of March, 1933, the said Administratrix will proceed to distribute the Assets of the said Deceased, having regard only to the claims of which notice and particulars shall have been given as above required.
