Dear Resident,

The following is an update on issues that have been raised and pursued by me with Dublin Corporation.

1. TRAFFIC LIGHTS AT TERENCE CROSS. The Traffic Study Group is recommending to the City Council a Filter Lane from Terenure Road North up Terenure Place. The effect of this should be to speed up the traffic flow during the peak evening rush-hour for traffic leaving town. This should alleviate the need for Rat-Running up Ashdale Road through Eaton Square and Eaton Road through Terenure Park.

It is also intended to put a Pedestrian Facility across Terenure Road East from Morris' Pub across to Doyle's Auctioneers. There will be a prohibition on traffic turning into Terenure Road East from both Terenure Road North and Rathfarnham Road.

2. SEATS IN EATON SQUARE. Mr. Gerald Barry, Dublin Corporation Parks Superintendent regrets the delay in providing the requested extra seating for Eaton Square. He wishes to assure all concerned that he is currently in the process of ordering seats, which, when taken into stock, will be erected as soon as possible, there afterwards.
3. DOGS SOILING FOOTPATHS. As soon as the Environmental Protection Agency Bill (1990) is passed, (expected this month), Dublin Corporation will be allowed to make owners of dogs soiling pathways, liable to prosecution and fine.


Dublin Corporation are presently awaiting authorization from the Department of the Environment to implement the bye-laws which were agreed recently by the City Council. This will allow them to choose areas for pilot "Kerb your dog"schemes.
