



Students vote to support VEC strike

THE 309 students at Bolton Street Technical College have voted to support a porters' strike at the college and to continue a sit-in protest at what they claim are now unhygicnic conditions as a result of the dispute. The Union of Students in Ireland took the decision at a general meeting yesterday.

The amon's education officer, Mr. Joe Duffy, said last night that the students had decided to support the porters, who are looking for a \$7.50 parity pay rise with Dublin Corporation workers, which had always existed in the past.

"We are protesting at the rundown condition that the college is now in as a result of the atrike. Rubbish has not been removed and toilets not cleaned out We are in total support of the porters, and the college will not continue to run while it is in this state." Mr. Duffy said

The students will stage their sitin on a roster basis. The students' protest will continue until such time as the porters' strike is settled. Mr. Dutty said. $1.5 + 5/9/3\nu$

Students plan food lifts

STUDIEN 15 who took over part of a Dublin college yesterday in support of striking maintenance workers would be kept going by "food lifts" throughout the weekend, it was stated last night.

The student leader Mr. Joe Duffy, explained that the "food lifts" to the students in a second floor administrativeoffice of the College of Technology, Bolton Street would be acranged at noon and six p.m. today and again etmoon tomorrow when supplies would be lifted to a window of the locked premises.

"Three hundred students met vesterday morning and voted for the occupation to continue," said Mr. Duffy, Union of Students of Ireland.

Department of Education towards the issue of pay increase due to the porters and the College cleaning stall and educational economies generally.

NOT LET LEAVE

It is believed that some 20 or 30 students are occupying the administrative office. They are led by Mr. Brian Stone, president of the Student's Union in the College. Yesterday College officials prevented the occupiers from leaving or other students joining them.

The Kevin Street College virtually closed vesterday. EDITORIAL

Students must organise together in a united front to seriously oppose the attacks being made on their position in society. This means raising the level of the student organisation (the student unions) to the point where the Unions are giving a lead to students in the fight against the cut-backs. This is in the face of serious attacks upon the entire education system at all levels (primary, secondary and third level) such as the fee increases, restriction of places, cut-backs in supply of equipment etc.

This process of raising the level of the student organisation started two years ago with the review of the Student Union constitution and the vote of last year changing the terms of reference of the S.U. to those of a defence organisation of students for the protection of their interests. The past two years in Bolton Street have been characterised by a growing awareness amongst the students of the arbitrary nature of the exam system and the improper teaching of courses. These student issues are the platform for the advancement of the student move-ment. Students must tackle each attack launched against them through the education system. We must tackle also the general attacks on the people being made by the Government. The attacks on education are but one front of the broad offensive against the people.

Bolton Street Students Union must mobilise against the fee increases through the Fee Boycott and adopt the slogan "we won't pay for the crisis of the rich". We must ensure that the extension of the College will alleviate the overcrowding and desperate social, recreational and health facilities. We must ensure that among our members there is a good grasp of the problems facing students on the education front, the political situation in Ireland and in the world situation.

Within the national and world situation it is important that students take a principled stand after discussing issues on these fronts, such issues as the "Pro Life" amendment, the National question, the taxation system, the war preparations of the superpowers and their allies and people's struggles throughout the world.

The idea of students fighting on a united front is very important because if the student movemenmt is not united, then it can only harm itself and thus the interests of students.

STUDENTS UNITE TO FIGHT THE CUTS.

The British Government plans to hold an election for yet another Stormont Assembly on Oct.20th. The elections will not remove the British colonial presence from Northern Ireland but are an attempt by the British to establish some sort of sham democracy in the Six Counties.

This election will only bring together all of the upholders of British Colonialism and Imperialism, such people as Molyneux, Paisley and the treacherous SDLP, traitors to the Irish people, into an assembly which will have its roots in the British presence in Northern Ireland and will work against the uniting of the Irish people into one truly independent Ireland.

This plan of devolved Government or "Rolling Devolution" as it is called by Prior, is to start as a talk shop and will get greater powers from Westminster as the British Government gains more confidence in Stormont and its ability to rule Northern Ireland in the interests of the British Government.

Haughey and Fitzgerald back the Stormont Assembly saying that it is a movement towards Irish unity. In fact it is to be used by these people in order to co-operate more and more with the British presence in Northern Ireland and evidence of this is the conviction of Jerry Tuite by the Irish Courts for alleged crimes committed in London, British police giving evidence in Irish Courts and all under the observation of a Northern Irish Judge.

The character of Imperialism is the domination by one country, in this case Britain, of another, Northern Ireland. This Assembly attempts to cover up this domination by Britain and to present the British military presence in Northern Ireland as a peace keeping force which is there to prevent civil war. In fact the British military have no more right to be in Northern Ireland than the Israelis have to be in Lebanon or the Russians have to be in Afghanistan.

These elections serve to "keep the pot boiling", to divide the Irish people along religious, sectarian lines and thus make Northern Ireland more governable by the British. This policy of destabilisation has been used always by the British no matter where in the world they have been, the splitting of Pakistan and India, the division of Turk and Greek in Cyprus. It is not only the British who use destabilisation of a country to dominate it. this tactic is used also by the USA in South America and by the Soviets in Africa.

The British ruling class has consistently established so called democracies around the world to serve the requirements of the British ruling class. The real nature of these Parliaments has been to cover up the domination of the subject nations. The establishment of these Parliaments according to the British ruling class have been to "train backward peoples for nationhood and western democracy".

These governments are in fact established to serve the interests of the British ruling class who are always in the background to send in its military forces for the establishment of "the rule of law", the nature of which is the law of Imperialists. It is not just the British who operate in the world in this way, but the Soviets also. When Polish crisis arose the and the Polish people revolted against their Soviet masters, the Soviets responded by rolling hundreds of tanks into Poland and tens of thousands of crack Soviet troops to crush the resistance of the Polish people. They did the same in Afghanistan and the Americans have done the same in Vietnamn and Korea.

The Charter of the United Nations clearly spells out the right of nations to self determination. The UN was established after the second world war, a struggle against fascism. The Charter of the UN also cleaarly states that there must be no imperialist domination of countries and no colonial rule.

True democracy can only be established in Ireland through the unity of the Irish people in one nation and genuine independence from colonial rule.



Letter to Fire Officer.

We, the Executive of Bolton St. Students Union wish to express our concern at the situation as regards fire safety in our main building.

During office hours there are two exits from the building. However, during library hours (5.30 pm - 9.30 pm) there is only one exit; there are very few fire doors, together with the fact that the college is like a "maze" inside and anyone entering the building for the first time would have great difficulty in finding an exit (as there are no exit signs). If this situation existed in any commercial premises I am sure it would be shut down at once - in reality the same issues are at stake human lives.

At present, due to the Porters' Strike, there is much combustable rubbish lying in the corridors - thus posing an even greater danger.

On many occasions we have 'phoned the fire officer but as yet no action has been taken. Recently in Ireland we have seen the devestating effect fire can have - how many more lives must be lost before action is taken?

Porters & Cleaners Strike

The porters and cleaners must be supported as a matter of principle and as a step on the way to resolving the dispute between themselves and the VEC, the Department of Education and thus the full restoration of classes for the students and apprentices, full members of the Students Union.

Any just struggle of people, whatever they be. Porters and Cleaners in the colleges.or liberation fighters in such countries as El Salvador or Afghanistan, must be supported. This is our clear duty as conscious members of society. For students or others to promote the idea that this issue of the strike is none of our concern is clearly wrong, both because we are conscious members of society and as students and members of the Students Union the defence organisation of students which fights for all students, members of the Union.

The fact that 4,000 (approx.) part-time students are not being given their classes along with eight groups of block release apprentices was promoted as being an irrelevancy to full-time students by certain people in the College, not all of whom are students. This promotion of narrow selfish self interest must be opposed and smashed by all who believe in justice and equal opportunity and all democratically minded people.

The justice of the stand of the Porters and Cleaners is clear from the history of the dispute. The pay claim which they made earlier in this year along with other groups of workers was passed by the Labour Court with the agreement of the Department of the Public Service.

This pay increase, a mere £7.50 was paid to the other groups of workers but not to the V.E.C .employees who work under the heel of the Department of Education and Martin O'Donoghue, the Minister against Education, who maintains that quote "Education is bottom of the pile, and bottom of the pile of bottom of the pile is third level education". The V.E.C. and the Department of Education maintain that Government sanction is needed to pay workers this increase, yet no government sanction was ever sought or approved by the Corporation, Dublin County Council or the Borough of Dun Laoghaire before this increase was given to these workers. This is obvious belligerence on the part of the V.E.C. and is further exposed in a letter from W.J. Arundel, Chief Executive Officer of the V.E.C. in which he asks the workers to return to work and concede their pay claim, end this "victimisation" of students (moral blackmail on the part of Arundel) and to consider the possibility of "a reduction in the job opportunies of your members in the long term" (a straight forward job threat). The belligerence of the V.E.C. is further exposed in their meeting on Sept.29th not in order to deal with the resolving of the strike, but to deal with the students from Kevin Street who were protesting against the loss of their

classes, by occupying the offices of D.I.T. (Dublin Institute of Technology). All of this and the fact that the V.E.C. issued a "report" on the occupation which reads more like a Stephen Spielberg film script (available in S.U. office) makes the V.E.C. a legitimate target for student protest. At the General Meeting held in the Kinema on Monday 4th Oct.students supported motions in support of the Porters and Cleaners who are on strike and in support of the students occupying the offices of D.I.T. in Mount Street. Verbal support is not enough. We must ourselves demonstrate our support on this issue and fight the cuts in education generally.

College Extension

Progress on the College extension at the moment is very slow. There has been no report from the Architect, Mr. Des McMahon (a studio master in 4th year architecture) to College Council.

The official reason for this is that the building design has reached a "crucial stage". The reality of any building programme undertaken by the V.E.C. and the Department of Education is that these programmes are desperately slow, witness the Canteen in Longford House, an Architect was installed in 1981 and that did not involve major building!

It is generally agreed by all who have contact with the V.E.C. that this building would take years and years to materialise. This will be the case unless we, the students, pressurise the V.E.C. and the Department of Education to build the extension as quickly as possible without turning it into a huge rabbit hutch. It is most likely that this extension will not alleviate any of the problems of overcrowding in the College. This increase in floor space will be about 60% - 70% for this part of the College but the increase in full-time student numbers will be about the same (60%). This gives no scope for the alleviation of the overcrowding. We must be on our guard to ensure that this does not happen!
